Annual HOA Members Meeting

The annual NHLHA homeowners meeting is always the second Saturday in July. This year the annual meeting is at 10am MDT on July 11. It is very important to either attend or mail in your proxy so that we have enough members to form a quorum.

Due to these unprecedented times, the Board decided to hold the meeting virtually. It is too difficult to predict what Covid-19 infection rates will be like in July. Safety is our number one concern, so an online venue will be the safest option. An online platform will give more HOA members the chance to safely participate given the current circumstances.

Water Repairs and Projects

This winter brought some challenging times for the water system. We want to thank our Water Manager Mike Kemp for his excellent service to the neighborhood. Late December there were two water line breaks on Lake Shore Drive and our line which runs under North Shore Club. In January there was a sensor malfunction in the pumphouse. Thanks to Mike Kemp's hard work, outages were kept to a minimum.

June 6 was a neighborhood service project to clean out the HOA lot on the upper fenced portion of our water supply. A special thanks to all who helped. I may have missed a few individuals on this list—if so, my apologies. We appreciate everyone's contribution. The vegetation was trimmed and cut away from the fence line.

A drainage channel is also being installed on Lake Breeze drive in front of that fenced lot across from the pump house. That area is notoriously swampy and mosquito prone. The drainage channel aims to help funnel the water appropriately to reduce swampy, still-water areas.

Water Evaluation

At last year's annual HOA meeting, the Board proposed conducting a formal water study to assess the condition of our system. Throughout the year, the Board received feedback from many HOA members. The Board hired an experienced water engineer, Brent Crowther of Civilize, PLLC Management and Engineering to evaluate the system, including the distribution lines, storage tanks, and pumphouse. The Board received a detailed 240-page report which evaluated the system's past history, current condition, and future recommendations. As part of the discovery process in May, the water engineer Brent Crowther, Bill Hall, and Mike Kemp dug up strategic portions of the line to evaluate the distribution system. They discovered that the galvanized portions on the water map were already replaced with PVC. This is very good news as those were some of the oldest sections of line. The Board is carefully reviewing the engineering report to present a plan to the neighborhood at our annual HOA meeting on July 11. We hope that you will attend the virtual meeting this year because your feedback is important.

Roads

Speed bumps were installed to help control speeding in the neighborhood. Help keep everyone safe by being mindful of the 10mph speed limit throughout the neighborhood. Many neighbors walk or bike the loop.

Gravel piles at either entrance were replenished and efforts were made to fill in the worst of the potholes. The improvements made to the entrance of Lake Breeze drive last year held up very well. If you notice a pothole on the HOA road in front of your home, please use the gravel to fill it. This helps keep HOA dues down. New street signs have been ordered and we hope to have them installed soon. Dust busting has been scheduled and should be completed before the 4th of July. It's important that dust busting happens after the rainy season so that it isn't prematurely washed away. Please attend the annual meeting for more road project info and updates.

Bear Sightings & Wild Fire Prevention

In May there was a bear attack at the Henrys Lake State Park. It's important to be bear aware since we live in bear country. To avoid attracting bears and other animals, keep your garbage indoors. If you use a trash service, you may only put out your garbage a few hours before your service comes. No garbage or food should be left out overnight.
